Summary

Chattahoochee Valley Community College has scholarships available through the **CVCC Foundation Sabal Trail Scholarship Fund** to support students interested in Fire Science and Emergency Medical Services.

Scholarships available for students in the FSC and EMS Program for Fall 2019 semester:

- **Sabal Trail Scholarships**
 - \$500-\$1,000
 - Tuition, books, equipment, and uniforms
 - Scholarship Committee to review and award scholarships
 - Scholarship Requirements
 1. Can be new or current student
 2. GPA -2.0 or minimum score of 145 on the GED
 3. CVCC Application for Admission form
 4. Student must have a declared major in Public Safety
 5. **FAFSA (After completing FAFSA on line, keep in mind it may take three to five business days for the CVCC Financial Aid Office to have access to your FAFSA. It is the student's responsibility to ensure that the FA Office has it by the application deadline.)**

Eligibility Requirements to apply

1. **Must submit the following:**
 - a. GPA -2.0 or minimum score of 145 on the GED
2. **Must submit all of the following forms:**
 - a. The student **must complete FAFSA** online at www.fafsa.gov with CVCC school code **012182**.
 - i. If FAFSA form is not submitted to Financial Aid by the application deadline, the application packet is not complete and will not be considered. **It is the student's responsibility to ensure that the FA Office has it by the application deadline.**
 - b. FSC and EMS Scholarship Application form.

Questions regarding the FSC and EMS Program scholarships should be directed to the Public Safety Office at 334.291.4963. If you are being considered for this scholarship, someone will contact you to schedule an interview. **Scholarship award decisions are made by the Scholarship Committee only.**

CVCC Foundation Scholarship Requirements

A CVCC Foundation Scholarship recipient will agree to participate in the following:

- **CVCC Foundation photo shoot**
Photos with article will be posted on CVCC's Website, released to the local Media, and used for promotional items for the Foundation.
- **CVCC Foundation video shoot**
CVCC Foundation Videos are short clips of scholarship students' testimonials. Videos will be posted on CVCC's Website and shown at events to promote the mission of the CVCC Foundation.
- **Attend and possibly speak briefly at Alumni and Foundation events**
The Foundation hosts different events to raise scholarship funds and awareness of the College. At times, a scholarship student will be asked to speak during the program at an event.

The student must not drop or fail a class during a semester. If the student does not complete the semester, withdraws, or drops a class, the student will be expected to refund the Foundation for any scholarship award monies received, unless there is evidence of extenuating circumstances. You must put your request in writing and attach any documentation, which would excuse you from repayment. This information should be submitted to the Foundation. Such request must be turned into the Financial Aid Office. You will receive notification by mail regarding the decision of the committee.
