

Summary

Chattahoochee Valley Community College has scholarships available through the **CVCC Foundation Sabal Trail Scholarship Fund** to support students wishing to earn their GED and gain employment.

Scholarships available for students in the Adult Education Career Pathways Program for spring 2019 semester:

- Sabal Trail Scholarships
 - o \$500
 - Tuition, books, equipment, and uniforms
 - Scholarship Committee to review and award scholarships
 - Scholarship Requirements
 - 1. Complete a Career Interest Exam
 - 2. Maintain a 90% attendance record
 - 3. Minimum score of 9.0 on TABE
 - 4. Minimum score of 145 on the GED or GED Ready test
 - CVCC Application for Admission form
 - 6. Student must have a declared major in Public Safety or Applied Technology
 - 7. FAFSA (After completing FAFSA on line, keep in mind it may take three to five business days for the CVCC Financial Aid Office to have access to your FAFSA. It is the student's responsibility to ensure that the FA Office has it by the application deadline.)

Funds are paid directly to the College on behalf of the student. A check will not be cut directly to the student.

Eligibility Requirements to be able to submit an application

- 1. Must submit the following scores:
 - a. Minimum score of 145 on the GED or GED Ready test
 - b. Minimum score of 9.0 on TABE
- 2. Complete a Career Interest Exam
- 3. Maintain a 90% attendance record
- 4. Must submit all of the following forms:
 - a. The student <u>must complete</u> FAFSA online at <u>www.fafsa.gov</u> with CVCC school code **012182**.
 - i. If FAFSA form is not submitted to Financial Aid by the application deadline, the application packet is not complete and will not be considered. After completing FAFSA on line, keep in mind it may take three to five business days for the CVCC Financial Aid Office to have access to your FAFSA. It is the student's responsibility to ensure that the FA Office has it by the application deadline.
 - b. Career Pathways Scholarship Application form.

You must meet the requirements in #1 - 4 for this application to be accepted.

CVCC Foundation Scholarship Requirements

A CVCC Foundation Scholarship recipient will agree to participate in the following:

- CVCC Foundation photo shoot
 - Photos with article will be posted on CVCC's Website, released to the local Media, and used for promotional items for the Foundation.
- CVCC Foundation video shoot
 - CVCC Foundation Videos are short clips of scholarship students' testimonials. Videos will be posted on CVCC's Website and shown at events to promote the mission of the CVCC Foundation.
- Attend and possibly speak briefly at Alumni and Foundation events
 - The Foundation hosts different events to raise scholarship funds and awareness of the College. At times, a scholarship student will be asked to speak during the program at an event.

The student must not drop or fail a class during a semester. If the student does not complete the semester, withdraws, or drops a class, the student will be expected to refund the Foundation for any scholarship award monies received, unless there is evidence of extenuating circumstances. You must put your request in writing and attach any documentation, which would excuse you from repayment. This information should be submitted to the Foundation. Such request must be turned into the Financial Aid Office. You will receive notification by mail regarding the decision of the committee.
